TERMS & CONDITIONS

Artists & Designers Pop-Up at gallery@oxo

In these Terms & Conditions:

Organiser refers to Blackdot Gallery.

Exhibitor(s) refers to any individual or collective selected to participate in the Artists & Designers Pop-Up.

1. Curatorial & Space Management

- The organiser retains full curatorial authority over the selection, layout, and presentation of all works in the pop-up.
- Exhibitors may not sub-let, share, or reassign their allocated space.
- The organiser reserves the right to relocate, adjust, or remove works at any point to ensure a cohesive and professional presentation.
- Only artworks or products that have been pre-approved by the organiser may be exhibited. Substitutions, additions, or changes without prior written consent will not be permitted.

2. Health & Safety

- Inflammable, toxic, or offensive materials are strictly prohibited.
- All fabrics used for display must be fire-retardant.
- The organiser reserves the right to remove any materials deemed unsafe or inappropriate.

3. Liability for Damages

- Exhibitors are responsible for any damage caused to the gallery walls, floors, furniture, fixtures, or any part of the venue during the event, including setup and de-rig.

4. Lighting & Electrical Equipment

- No additional lighting or electrical devices may be installed or modified without written permission from the organiser.
- All electrical equipment brought by exhibitors must be PAT tested by a qualified electrician prior to installation. Proof of certification may be required.
- On-site PAT testing, if needed, may incur extra fees.

5. Insurance

- The organiser is not responsible for loss, theft, or damage to any artworks, products, or personal property at any stage of the event (setup, exhibition, or dismantling).
- Exhibitors are responsible for arranging their own insurance, including public liability cover.

6. Shipping, Delivery & Sizing

- Exhibitors are fully responsible for the delivery, installation, and collection of their work, as well as any associated costs.
- Recommended maximum dimensions for individual works:
 - 2D works: max. 80 cm on the longest side.
 - 3D works: max. 80 cm (W) × 80 cm (D) × 200 cm (H).
 - Wall-mounted works should not exceed 5 kg.
- Any changes in the type or scale of exhibited work must be communicated and approved in advance.

7. Furniture & Display

- Basic display furniture will be provided: tables for product-based exhibitors and clothing rails for fashion exhibitors. Additional items such as plinths, shelves, or mannequins are not guaranteed and should be brought by the exhibitor if required. All display setups must be pre-approved by the organiser in advance.
- A limited number of chairs may be provided, subject to availability.

8. Force Majeure

- In the event of cancellation due to circumstances beyond the organiser's control (including but not limited to war, fire, strike, venue closure, or natural disaster), no refunds will be issued and the organiser will not be held liable for related losses.

9. Non-payment Clause

- The organiser reserves the right to withdraw any offer of participation if the exhibitor fails to complete payment by the deadline.

10. Promotion & Publicity

- Exhibitors agree to provide promotional materials (images, videos, text, etc.) to support the marketing of the pop-up.
- By submitting materials, the exhibitor grants the organiser and its partners a non-exclusive, royalty-free licence to use this content for promotional purposes (web, social media, press, digital, and print).
- All submitted content must be original and not infringe upon third-party rights. The exhibitor retains copyright.

11. Third-party Agreements

- Any agreements between exhibitors and third parties (e.g. couriers, fabricators, assistants) are the sole responsibility of the exhibitor. The organiser assumes no liability in such matters.

12. Accuracy of Information

- While the organiser will take care to ensure the accuracy of all promotional materials, it does not accept responsibility for typographical errors, omissions, or miscommunications regarding names, descriptions, or other details.

13. Agreement
